WHAT'S NEW IN What's New In Cumru

Cumru Township has undergone many changes in the past year. The Cumru Township Fire Department was created as a result of the merger of the Grill, Gouglersville and Cedar Top Volunteer Fire Companies. The consolidation allows the Fire Department to centralize services, which will result in cost savings to the Township. The Township, through a grant from the PA DEP, has constructed and opened a new yard waste facility on Poplar Neck Road. The Police Department is currently implementing new software designed to improve quality of responses.

Several changes have occurred in staff, as well. In July, Jim Beane was hired as the new Assistant Public Works Superintendent. Jim came to Cumru from West Reading Borough where he was the Public Works Department Foreman. Also in July, the Township hired Samson Gausch as the new Park and Recreation Director. Sam has served as a Head Playground Leader at the Cumru Township Summer Playground program for the past five years. Finally, the Township has accepted, with regret, the retirement of Chief of Police Brian Hiester. Chief Hiester will be succeeded by Detective Sergeant Jed Habecker, who will take the reins when Chief Hiester retires on September 30th. The Township welcomes our newest staff members and wishes Chief Hiester well in his future endeavors!

With the many changes in personnel, the Township is focusing on improving services to the residents. We will be focusing on new ideas for the newsletter for the next issue. We will also be looking at how to better communicate to the residents. The members of the Parks and Recreation Board are working on expanding the variety and frequency of programs and events. There is a great deal of change taking place in Parks and Recreation. Carol Sigworth, who had been the Director for several years, left to take another position. Carol's dedication and conscientious attitude will be missed. The Parks and Recreation Board reviewed and edited the job description for the Park and Recreation Director. Resumes were solicited and candidates interviewed and evaluated. After a thorough process, Samson Gausch was selected as the new Director. There will be many qualities that the new Director will need to possess, but primary among these qualities will be the ability to deliver on our mission statement: "To enhance the quality of life for the residents of Cumru Township by offering recreational opportunities and developing and preserving recreational areas and facilities."

Board members participate actively on the newly-formed Governor Mifflin Coordinating Council and the Environmental Advisory Committee (EAC). The EAC will offer the 2nd annual Earth Day, at the Warren Center, on Saturday, April 23rd, 2011.

Our annual Breakfast/Lunch with Santa was held on Saturday, December 5, 2009. A total of 100 people attended the breakfast, and another 82 individuals attended the lunch. A good time was had by all who attended, and the children were pleased to be able to talk with Santa. The Bunny Breakfast was held on Saturday, March 27, 2010. Slightly more than 100 attended the breakfast, and had a chance to speak with the Easter Bunny. Another 200 children were in attendance for the Easter Egg Hunt (ages 2-4; 5-7; and 8-10). Hold the Stormwater, Please! tips for stormwater management on your property



DID YOU KNOW:

• We depend on rainfall soaking into the ground to recharge our groundwater levels.

• Increased number of impervious (non-porous) surfaces, such as asphalt and rooftops, result in fewer opportunities for rainfall to soak into the ground causing flooding and increased pollution of our streams.

• Low groundwater levels result in critically low or even dry creek beds and diminished drinking water supply during periods of reduced rainfall.

Here are some ways you can help in your own backyard:

Substitute porous surfaces for impervious ones.

Patios, walkways, driveways, and parking areas can be constructed with

porous materials that reduce stormwater runoff. One option is special blocks or



pavers with voids that can be filled with gravel or planted with grass that allow stormwater to soak into the soil.

Direct stormwater to areas where it can seep into the ground.

Do any of your downspouts direct rooftop runoff down the driveway into the street or directly into a stream? Redirect those downspouts away from the foundation of your home to a grassy

area, seepage pit, mulched bed, or rain garden. Use a PVC extension or pipe.

A Hold stormwater for use or release later.

Use a rain barrel to retain stormwater coming off rooftops for reuse in gardens or to release at a later time. For best results, direct overflow from
your rain barrel to a more porous area such as a mulched bed or a rain garden.





Plant more trees, shrubs, and mulched beds.

Trees, shrubs, and mulched beds with flowers will intercept and infiltrate rainwater better than mowed lawns. Consider planting one or more large canopy trees, such as maples and oaks. Each large tree will intercept over 1,000 gallons of rainwater each year.

Installing a Pool

Are you planning on installing a pool that holds more than 24 inches of water? If so, you need a Building Permit.

Pennsylvania state codes are uniform when dealing with requirements for in-ground, above-ground and on-ground swimming pools, hot tubs and spas. If any one of the previously mentioned hold more than 24 inches of water, a building permit is required. In almost every case, you will also need an electrical permit. In many situations you may also need a fence which will also require a building permit. The codes are intended to provide protection against potential drowning, near-drowning, and electrocution due to faulty electrical work. The Township also has zoning restrictions regulating where any of the above can be located on your lot. So if you are thinking of installing any of the above, please call the Township for information.

A great number of permit violations seem to occur in the summer months. The violation is usually because the building inspector or zoning officer notices an inflatable swimming pool with no building permit on file. Although the initial cost of an inflatable pool may be low, keep in mind that additional expenses will be incurred to meet all codes.

Don't Top Off at the Pump!

Did you know that "topping off" gas tank after the nozzle clicks can cost money and cause pollution to our streams?



Overfilling can cause fumes to escape and cause spills of gasoline onto the pavement which washes into storm drains and then streams.

Forcing extra gasoline into the tank can lead to poor efficiency and affect the vehicle's emission system.

Your car's vapor recovery system may actually feed this extra gas back into the pump.

TIPS FOR SEPTIC SYSTEM OWNERS

One source of bacterial pollution to our local creeks appears to be pollutants leaking from septic fields. Here is an important checklist for septic system owners to review:

- Do not connect foundation sump pumps or other "clean water" discharges to your septic systems.
- Inspect your septic tanks and any distribution pumps every year. Measure the level of sludge build-up and inspect the baffles for scum. Pump your septic tank at least every 3 years (or sooner as indicated by your annual inspection of the tank).
- t Solt Croundwater

- Avoid using a garbage disposal.
- Do not pour old medicines or strong cleaning agents down the drain. They will kill beneficial bacteria that break down the waste in your system.
- Keep trees and shrubs at least 35 feet away from your field to prevent roots from plugging or breaking pipes.
- Route surface water drainage and snowmelt away from your absorption field to avoid inundatoin of your field.
- Locate your absorption field as far away as possible from surface water to reduce its potential of becoming a source of contamination.



OPERATION SAVE A LIFE Operation Save A Life

The Cumru Township Fire Department has received 84 smoke detectors from a program coordinated by the Pennsylvania Fire Commissioner and WFMZ-TV

Channel 69. These smoke detectors were made available as part of a grant program intended to help low income residents, the elderly, and families with children that reside in the Township of Cumru.

WFMZ-TV has dubbed this program, Operation Save A Life. The terms of this grant require that the Cumru Township Fire Department physically install the detectors in residents' homes. There is also paperwork that must be completed by the Fire Department and residents to fulfill the grant requirements by the PA Fire Commissioner.

Because there are a limited number of smoke detectors available, an application is available on the WFMZ website at: www.wfmz.com and click on the Operation Save A Life icon, or at www.grillfire.org and also click on the Operation Save A Life icon. Once the application is completed and you have been selected to participate in the program, you will be contacted by a representative of the Cumru Township Fire Department.

COM Cumru Township Commissioner's Award

On April 20, 2010 District Attorney John T. Adams and Senator Michael A. O'Pake were awarded the Cumru Township Award.

District Attorney John T. Adams

From 1994 through 2007 John was an associate and then a partner at the Law Firm of Linton, Distasio, Adams & Edwards, P.C. where he primarily practiced in the area of criminal defense & litigation.

In November 2007, he was elected as District Attorney of Berks County and was sworn in as District Attorney in January 2008. John is a member of the Advisory Board of Crime Alert Berks County, a Member of the Fraternal Order of Police, Lodge #71, a Member of the Board of the Berks Connections/Pretrial Services formerly known as Berks County Prison Society, a Member and Executive Committee Member for the Criminal Justice Advisory Board, a Member of the Berks County Chiefs of Police Association, and Chairman and Member of the Berks County Bar Association Criminal Law Committee.

In 2009, John was elected to the Executive Committee of the Pennsylvania District Attorney's Institute and was subsequently elected to the Executive Committee of the Pennsylvania District Attorney's Association in 2010.

He is married to Elizabeth Adams and has two daughters, Julia and Paige Adams, and two step-daughters, Adrienne and Corie Lutz. He has been a resident of Cumru Township for 19 years.

The Senator has assisted with many other grants for Berks County and the Governor Mifflin Area, including for law enforcement, the Mifflin Area Community Library, and youth athletics.

Senator O'Pake has also advocated economic growth in the area through funding for area highway improvements and assisting the Township with respect to highway regulations.



Cumru Township felt the effects of the recession in 2009

The overall real estate assessment for the Township, from which real estate revenue is obtained, remained virtually unchanged for 2008, 2009, and 2010. In fact, it has decreased since 2007.

With respect to planning and building, the Township had a steep decrease in the number of new subdivision and land development plans and building permits.

The estimate of the Township's Minimum Municipal Obligation for Pensions for 2011 is over \$650,000.00. This estimate may increase further during 2010.

The Township's general fund in 2010 has a decrease in revenue by at least \$400,000.00 because of Kenhorst Borough's decision to not renew the police services agreement.

Because of these items and other mandated cost increases, the Board of Commissioners adopted an ordinance in December 2009 that increased the general real estate millage by one mil. This increase was necessary to cover a projected general fund deficit for 2010 of over \$1million.

- No stumps, 4 x 4's, railroad ties, large lumber, etc.

All bundles (shrubs, twigs and small wood, etc.) must be tied &

bundled securely (36 inches long and 18 inches in diameter) no larger.

The weight limit must not exceed 35 lbs. per item.

No more than a small pick up load per household.

HAVE YOU CONSIDERED A RAIN BARREL?

By collecting rain water and storing it in a rain barrel, you'll have water for watering flowers and gardens. Many home improvement stores, as well as websites, sell rain barrels for this purpose.

BUSINESS RECYCLING

Do you own, manage, or operate a business within Cumru Township? If so, you are required to recycle. Township Ordinance No. 458 requires commercial, and institutional establishments to recycle high grade office paper, aluminum, corrugated paper, glass, etc. Businesses must forward a report of tonnages recycled to the Township at the beginning of each year. This report must be prepared by the businesses' contracted recycling collector.

Remember... each item recycled saves landfill space. REDUCE... REUSE... RECYCLE

CUMRU TOWNSHIP COMPOSTING FACILITY and LAWN GRASS CLIPPINGS The new Cumru Township yard waste recycling center at Poplar Neck is open to Cumru Township residents to drop off their yard waste for recycling. For the dates and rules, please see the accompanying charts. Grass clippings will NOT be accepted at the Cumru facility. Municipal composting is governed by the standards set forth by the Pa. Department of Environmental Protection (Pa.DEP) and lawn grass clippings are not be used in municipal recycling. Lawn grass clippings are high in nitrogen and high in water content and when composted by themselves in large quantities give off foul odors as they decompose. Also, many homeowners use or have lawn services that use chemical fertilizers, pesticides and herbicides on their lawns. Grass clippings from such lawns can carry residues of these chemical fertilizers, pesticides, and herbicides which is another good reason to prohibit lawn grass clippings from being dumped at municipal recycling centers, including Cumru Township's facility. Homeowners can recycle their lawn clippings at their respective properties. The easiest way is to simply let the clippings on the lawn where they will decompose and feed and mulch your lawn- this is called grasscycling. There is no necessity for a composting mower, however they do a better job. Contrary to some popular misconceptions, grass clippings do not contribute to thatch as the clippings decompose readily. And remember to reduce or eliminate chemical fertilizers, pesticides, and herbicides on your lawn as you and your family will be spending time in contact with your lawns ; plus, the residues from these chemicals can be washed off the lawn and into the storm sewers by heavy rain and then into our local streams and water supplies. Alternatively, the nitrogen rich lawn grass clippings can be bagged or raked and composted with other materials like dried leaves or shredded newspaper which are high in carbon and mixed in a compost pile on the property. For more in depth information on lawn grass composting, please Google: Lawn Grass Compost Please utilize your Cumru Township Yard Waste Recycling Center as well as the township curbside recycling for glass, plastic, etc. and also the Western Berks Recycling Center for recycling of other difficult items. The use of these services helps to keep your Cumru Township Trash collection fees down - it saves you money now and in the future, saves landfill storage space, and contributes to less trash in our environment, in the place we live. **REDUCE, REUSE, RECYCLE, RESTORE IN CUMRU TOWNSHIP**



The Cumru Township Summer Playground program was once again held this summer. The program ran a six-week schedule from June 28th through August 6th. More than 150 children, ages 4 to 13, participated at the various locations, which included the Warren Recreation Center and Junior playgrounds, the Montrose Manor Playground, and the Gouglersville Fire Company playground. Playground was held daily, Monday through Friday, from 9am to 1pm. An evening playground was held from 6:30pm to 8:30pm at Gouglersville. On Fridays, the children attended field trips which included bowling, playground Olympics, swimming at French Creek State Park, the Reading Museum and Planetarium, and Ozzys. The playground program culminated in a Carnival held on August 6th at the Warren Recreation Center. It was a fantastic summer and we look forward to an even better program next year!





Sewer Vents

Sewer vents and clean-outs are a critical parts of every building's sanitary sewer lateral. They provide access for repair, maintenance and inspection of the sewer pipes that convey sewage from a building to the Township's sewer collection system. The sewer vents and clean-outs are owned by and are the responsibility of the property owner. The area around the sewer vents and clean-outs must be kept clear of vegetation, landscaping and other permanent structures.

Leaf Collection

Leaf collection on all dedicated roads is scheduled from the second Tuesday in October and continues for nine weeks or until the first significant snow fall. Leaves should be placed along the gutter line for collection. Leaves should not be placed out in bags or containers. Leaves in bags or containers will not be picked up during this time. The leaf collection crew will work through the Township on a continuing basis. Due to weather conditions and varying amounts of leaves the leaf collection crew cannot follow a published schedule. Leaves mixed with branches and other yard debris will not be collected. Leaves may be placed in regular refuse containers January through September. Township residents are encouraged to mulch or compost at their residences if possible.

Potholes

The Highway Department fills potholes all year round. Please call 610-777-1343 to report potholes and a crew will be dispatched.

2010 Street Improvement

In 2010 Cumru Township has repaved 4,300 lineal feet Lakewood Drive from Flying Hills Drive to Canterberry Circle. Lakewood Drive was selected for repaving because of its poor condition and the volume of traffic that uses the road. The cost of the project is \$232,544.75.

Tree Trimming

Trees and vegetation must be trimmed to provide at least seven and one half feet (7'-6") of clearance above sidewalks and at least fourteen (14') of clearance above streets. Low branches can damage vehicles and block sidewalks. Ordinance No. 137.



Refuse Rates*

Residents are reminded that there exists a "two-tiered" refuse collection rate in Cumru Township. Resolution #578, adopted on December 20, 2005, established those rates as follows:



- \$142.00 annually for a dwelling with 2 or more occupants

- \$127.00 annually for a dwelling with a single occupant.

The services provided under this fee structure include:

- Weekly refuse collection
- Biweekly recycling
- Biannual "bulky item" collections

*These rates may change as a new contract was awarded in September, 2009

SEWER BACK UP? FIRST CALL TOWNSHIP

Those residents of Cumru Township, whose dwellings are connected to the Township sanitary sewer system, who suspect that their sanitary sewer might be blocked, should first call Cumru Township Utilities Dept. at 610-777-1343 (24/7). Upon receipt of such call, Township crews will be dispatched and will determine if the problem exists in the Township-owned portion of the sewer system. If the problem is in the Township lines, the crew will take corrective measures. There is no charge for this service. If it can be determined that the back-up is not in the Township portion of the system the property owner then will be advised to contact a plumber. If the problem does exist in the main line, by first looking at it, the property owner will be able to avoid incurring the cost of a plumber. Persons whose homes are served by on-lot septic systems should NOT follow this procedure, as their dwellings are not connected to the public system.

POLICE REPORT Spring Safety Tips from the **Cumru Township Police Department**

Bicycle Riders - Stay Alert

Ride defensively and expect the unexpected. Keep both hands ready to brake, and be aware of traffic around you. Many accidents occur at driveways or other intersections, check for traffic and always look left-rightleft before beginning your ride and entering roadways.

Make eye contact with drivers, assume that other drivers don't see you until you are sure that they do. Eye contact is important with any driver which might pose a threat to your safety.

Scan the road behind, learn to look back over your shoulder without losing your balance or swerving. Some riders use rear-view mirrors or mirrors attached to the frames of glasses.

Keep a look-out for obstacles in your path. Watch out for potholes, sewer grates, cracks, railroad tracks, loose gravel, rocks, broken glass, and other debris can cause a bicyclist to lose control. Before going around any object, look ahead and behind you for a free gap in traffic. Plan your move, and then signal your intentions. If you are unsure, or lack the skill to handle an especially rough area, pull off to the right side of the road and walk your bicycle around the rough area.

Be especially careful in wet weather, riding on wet roadways is hazardous. Water can cause you to slip and make your brakes work improperly. Wet weather also poses visibility problems, for cars and bicycles.

See and be seen, day or night

Wear proper clothing, clothes that make you more visible. Wear neon, fluorescent, or other bright colors and keep clothes close fitting to avoid being caught in the bicycle's moving parts.

A day-glo flag (as tall as possible) should be attached to the back of a child's bike, so the child can be seen easily by other drivers.

Children should ride only during daylight hours. After dusk, children should walk their bike home or have someone pick them up instead.

Be cautious when biking at night. If you have to ride at night, equip your bicycle with a white headlight and a red tail light, and front and rear reflectors. Wear reflective clothing or materials, especially on your ankles, wrists, back, and helmet. A reflective vest or reflective tape sewn on clothing makes you far more visible at

night. Ride in areas that are familiar and on streets that are brightly lit.

Clothing

Long pants and long-sleeved shirts cut down on scraped elbows and knees. Clothes should fit snugly; use ankle clips or rubber bands to keep pant legs from catching in the gears, chain or on the bike. Experienced bikers prefer shorts. Gloves reduce hand fatigue caused by continually gripping the handlebars and also offer some protection for your palms in case of a fall. Use of shatterresistant protective eye wear is also recommended.

Headphones should never be worn, as they hinder the rider's ability to hear traffic.

In-Line Skating or Skateboarding

In-line skating and skateboarding are popular activities. Be careful! These activities can lead to serious injuries to the head, arms and legs. Be smart, wear the protective gear.

- Always supervise young children.
- Make sure all equipment is in good condition and fits properly.
- Always wear a helmet, and replace it every 2-3 years or after a major impact.
- Wrist guards will help to prevent wrist fractures in case of falls.
- Cuts and scrapes can be reduced by wearing elbow and knee pads.
- Teach children to choose a safe location, away from traffic, that has a smooth surface.

Teach and follow the rules:

- Learn and teach how to stop and control speed.
- Do not wear headphones.
- Do not skate or skateboard at night or in wet conditions.
- Stay alert! Keep your eyes on the surface ahead; watch for other people, cars and hazards such as cracks and rocks.
- Respect others on the path.

- The Township of Cumru's, **Ordinance #467** states, "it shall be unlawful for any person to engage in rollerskating, skateboarding, or to ride upon or propel any coaster or toy vehicle upon:
- A. any street except in order to cross the roadway; or
- B. any sidewalk located in a business district except that nothing ... shall prevent a pedestrian from pulling a coaster or other toy vehicle, with or without a rider, upon a sidewalk."

Vehicle & Vehicle Contents: Anti-Theft Tips

Lock your vehicle and pocket the keys

The majority of stolen vehicles are left unlocked, often with the keys in the ignition. Whether you leave it for a moment or for several hours, always lock it and take the keys with you. NEVER leave your vehicle with the engine running. This is an open invitation to the "joyrider".

Secure Valuables and Parcels

Never leave unattended in your vehicle, check books, credit cards, laptop computers, money, brief cases, purses or other personal items. Lock valuables in the trunk.

Park in Well-Lit and Busy Areas

This is important for both your personal safety and the protection of your automobile and its contents.

Secure Your Registration

Carry your vehicle registration and insurance cards with you.

Identification

Criminals have also found it profitable to steal equipment and accessories. Engraving tools are available to mark equipment and accessories such as batteries, stereos, GPS Devices, and Satellite Radios.

Texting While Driving

According to a recent study by the American Automobile Association, the risk of a car accident increases by 50% for people who text message while driving. A few states have banned texting while driving and Pennsylvania is currently reviewing legislation to follow suit.

A growing body of research suggests that texting while driving is a rapidly increasing problem. What's clear from this research is that the more finger involvement you have, the more dangerous you are. Talking on a cell phone affects driving, but when you start to do things like dialing, texting, or searching your MP3 player, you're more likely to have speed variability and lane variation.

Driving habits are severely impacted when texting, probably because texting forces people to look down in addition to moving their fingers. Two of the effects were slowing down dramatically and weaving outside their lane.

When you're attention to the road is distracted you're a hazardous driver to yourself and everyone else. If it's absolutely necessary that you need to use a cellphone or other electronic device while driving, drive to a safe place and stop your vehicle before doing so.

BE AWARE

Know what is going on in your neighborhood, don't be afraid to report suspicious persons and to write down license plate numbers. The general rule is to use your intuition. Go with your gut feeling – if it doesn't "feel right" it probably isn't.

If you witness a crime or suspicious activity, notify the Cumru Township Police Department immediately. If it's an emergency, telephone 911. If you would like to speak to an officer or the incident is a non-emergency, telephone 610-655-4911.

Because even though our police are doing an excellent job, they need the help of an involved citizenry. Our police need people who can be their "eyes and ears", watching out for and reporting suspicious activity in their neighborhoods. Do not investigate suspicious activity yourself – let the police do it. They have the training and the skills. Do not try to detain any criminals or suspicious individuals and do not disturb any evidence.

Please know that if you choose, you can remain anonymous when you make the call. Your call could save a life, prevent an injury, or stop a criminal act – please get involved, we need your information to make your home and workplace, a safer community!

DEPARIME Many Changes for the Cumru Fire Department

This year has been very busy to say the least for the Fire Department. Several projects that have been in the works are moving forward and some other projects that were not anticipated are being dealt with.

The first item on the agenda has been the completion of the consolidation of the three existing fire companies-Cedar Top, Gouglersville and Grill. This has been done, as of July 1, 2010. With this consolidation, all three stations will remain in operation, but the guidance will be from the Township Fire Department. This consolidation will reduce the operating expense and allow for the entire township to benefit from the knowledge and experience of all our firefighters.

Along with the consolidation, an organizational structure was developed to provide leadership to the new organization. An interview board was formed with individuals from outside Berks County to sit down and interview all the potential new fire officers. And from this process, nine individuals were appointed to create the first officers of the Cumru Township Fire Department.

The second item on the agenda has been replacement of aging fire apparatus. The 1972 Mack 75' Tower Ladder Truck located at the Grill Station. This unit has served the Township and neighboring residents very well, but as the age of the unit increases, so does the cost to keep it in service. The parts are becoming scarce for the age of truck and are not readily available. This unit has been deemed "Out of Service" by the Township due to a mechanical problem that would be very costly to repair. Specifications were developed by the apparatus committee and several manufacturers offered their bids for a used/demo/new Tower Ladder. After a lengthy review of all bids and manufacturer demonstrators, the Sutphen Corporation from Ohio has been awarded the contract to construct a 100' Tower Ladder that the CTFD will take delivery of in January 2011. The \$900,000.00 for the cost of this unit will be offset by a \$380,000.00 grant received from the Assistance to Firefighters Grant from the Federal **Emergency Management Agency.**

The other unit that wasn't expected to be replaced was the 1990 Pierce pumper, located at the Cedar Top Station. This unit serves several functions, including the day to day use by the three full time firefighters. This engine was placed out of service on March 15 due to a blown motor. At that time, the Board of Commissioners voted not to repair this unit and the apparatus committee was tasked with creating specifications for an engine. Bids were received and



reviewed for a demo/stock unit. Toyne Inc. from Iowa provided a 2008 unit that closely matched the apparatus committee specification. This unit arrived at the Cedar Top Station in May 2010 and is currently having all the equipment mounted by the Cumru Township Mechanic. The cost for this unit was approximately \$355,000.00, a considerable savings of over \$150,000.00 for a custom built pumper.

Next, to help guide the future of the department a strategic planning committee was created that was comprised of representatives of the Board of Commissioners, Township Manager, Fire Chief, Firefighters and residents of the township. The objective of this committee was to create goals and objectives for the CTFD to meet, accomplish or exceed for the next five years. The final version of this plan was presented to and accepted by the entire Board of Commissioners on May 18, 2010.

Last, the vacant offices in the lower level of the Cumru Township Building were turned over to the CTFD for utilization by the Fire Chief, Volunteer Fire Officers and Career Firefighters. This in essence has created a fire headquarters for the foreseeable future.

As one has read, many different things are on the agenda and everything will take extensive work to accomplish and keep intact once in place. And along with all this, the three stations are still training to become skilled and proficient in all areas of firefighting. The Cumru Township Fire Department is based on the dedication of the 60+ men and women that volunteer their time and have a sense of dedication and pride for the service that they provide. Anyone interested in becoming a member of the department are encouraged to stop by one of the stations, or during the day at the Township Building. Even if you're not interested in becoming a member, you are more than welcome to visit any or all of the fire stations in Cumru Township.
