In ground pools & above ground pools require 2 electrical inspections, all others require only one @ \$65.00 each inspection.

Special Notes:

2. Depending upon the size of the project, other permits (e.g., storm water, E&S) may be required.
3. Water shall not be discharged onto neighboring properties.
4. Water shall not be discharged onto a drain field.
5. Water shall not be directed into a well area.
6. Pools are not filled or drained by the Cumru Township Fire Department.
7. Re-inspection fee is \$100.00.
8. Commercial pool may require additional review by the Sewer Department and/or the Municipal Authority.
