

RESOLUTION NO. 886

RESOLUTION OF THE TOWNSHIP OF CUMRU, BERKS COUNTY,
PENNSYLVANIA, FIXING THE FEES FOR THE ISSUANCE OF SEWAGE
PERMITS AND INSPECTION OF ON LOT SEWAGE SYSTEMS

IT IS HEREBY RESOLVED by the Board of Commissioners, CUMRU TOWNSHIP, BERKS
County and the Commonwealth of Pennsylvania, as follows:

SECTION 1. The fees for the consideration of and issuance of Sewage Permits and Land Development
Subdivision Modules offered by Berks Envirotech, Inc. relating to the administration of the Pennsylvania
Facilities Act, P.L. 1535, No. 537 as amended, (35 P.S. 750.9) will be as follows:

SECTION 2. Schedule of Permit fees:

ON-SITE SEWAGE SYSTEMS

Site Investigations – per lot \$500.00

Verification of prior SEO testing – per lot \$100.00

Permitting – per application

 New & Replacement Systems \$700.00

 Repair \$300.00

 Holding Tanks \$300.00

 Permit Renewals \$50.00

 Additional fee for designs requiring P.E. review \$150.00

SECTION 3. Required System Inspections every 3 years:

 This fee is set annually by the Board of Commissioners.

SECTION 4. Administrative expenses:

 PLANNING MODULE OR PLAN REVIEW – per hr. \$150.00

 MILEAGE – current IRS rate

 POSTAGE – actual

 ADDITIONAL COSTS – applicant will be billed by Cumru Township for
 supplemental services by the SEO, including but not limited to additional site
 investigation.

SECTION 5. The Subdivider/Applicant shall pay Cumru Township all costs for permitting
services rendered listed in section 2. **PRIOR TO PERFORMING** any services. The fees for
administrative expenses, including but not limited to processing planning modules, plan review,
and additional site investigation will be billed upon completion of work.

SECTION 6. The Applicant and/or Subdivider shall be responsible for obtaining and paying for
probe excavation activities connected with on site testing.

SECTION 7. All Resolutions and parts of Resolutions inconsistent with this Resolution are hereby superseded.
